Students will not be able to complete the class remotely since all exams will be in-person.

Topics and Schedule

Tradeoff and Choices (Week 1), Supply and Demand (Week 2-4), Market Interventions (Week 6), Production and Costs (Week 7), Perfectly Competitive Markets (Week 8), Monopoly and Imperfect Competition (Week 9-10).

Textbook and Homework

The required textbook is Microeconomics, 3rd edition by Karlan and Morduch. You also need to purchase the associated access to the publisher's online homework site (MH Connect) for the purpose of homework. You are highly recommended to purchase the bundled e-book and website access in the MH Connect section on Canvas. A two-week free trial is available for those who are unsure about continuing in the class.

Final grades will be curved as necessary to reach a median grade for the class between 2.9 and 3.1.

Class Format

Each week, you will need to read chapters from the textbook and finish the Smartbook Assignments at the end of each chapter on MH Connect. They are graded based on completeness, due by the end of Thursday. I will cover those chapters during lectures, with the expectation that you have read them beforehand. A problem set will be assigned as homework and due by the end of Friday.

There will be three writing assignments throughout the quarter, where you will describe the issues presented in the article that you find, and then summarize how the material taught in class explains the information, events, or phenomenon in the

article. Please check the writing assignments module in Canvas for detail.

Office hour is remote through Zoom. If you have difficulty coming to office hour, feel free to make an appointment through email. **Please check your UW email in a timely manner for the purpose of this course.**

Makeup Policies and Flexibility

Your lowest homework score AND two lowest Smartbook Assignments score will be dropped before the final grade is calculated. For any other reason, you will not be given an extension for your assignment but get a zero and that score will be dropped, given that you have finished all other assignments. Any technical issue regarding to MH Connect should be consulted with their tech support as soon as possible. (Start the homework early)

Writing assignments can be submitted up to 3 days late, with a 10% per day grade penalty (A 3-day late assignment will receive 70% of the score it would have received if turned in before the due date).
